WHEREAS, the Annual Budget for the Township of Edgewater Park Fire District No. 1 (the "Fire District") for the fiscal year beginning January 1, 2017 and ending December 31, 2017 has been presented before the Board of Commissioners of the Fire District at its open public meeting of November 1, 2016; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.) and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$446,330, which includes an amount to be raised by taxation of \$406,000, and Total Appropriations of \$446,330; and





The only expense that increased by greater than 10% is Office Expense because it is expected that equipment will be replaced. The 2017 operating budget increased by \$7,730 or 1.3% which is mostly due to the increase in the contract with Beverly to provide fire protections services for Edgewater Park Township.

The Tax Levy increased by \$7,938 resulting in a minimal increase in the tax rate equal to \$.001
