WHEREAS, the Annual Budget for Edgewater Park Township FD No. 1 (the 'Fire District') for the fiscal year beginning January 1, 2026 and ending December 31, 2026 has been presented before the Board of Commissioners of the Fire District at its open public meeting of December 9, 2025; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$777,640.00 which includes an amount to be raised by taxation of \$626,488.00 and Total Appropriations of \$777,640.00; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 9, 2025 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2026 and ending December 31, 2026 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the Fire District will consider the Annual Budget for adoption on January 13, 2026.

The overall 2026 proposed budget increased by \$88,368 (12.8%) over the 2025 Budget, this increase is attributed to the cost of the new outside services agreement.

Revenue A. Increase in unrestricted Fund balance utilized of 458% or 91,602. This is attributable to new shared service agreement. B. Decrease in restricted fund balance of 53,367 or 100%. Prior years was for the Fire Official SUV. C. Decrease of 3,010/100% for supplemental fire services revenues as nothing was received in 2025. Appropriations A. Decrease in salaries/wages for administration of 25%, based on need. B. Decrease in office expense line 7,855/100%, this was allocated in various lines. C. Increase in professional services of \$21,500 or 91.5% which is attributable to additional legal/accounting expenses. D. Increase in fringe benefits of \$1,000 or 100% under costs of operations to properly budget for FICA. E. Outside services increased by 122,140/34.9%. This is based on new agreement. F. Decrease in advertising of 86%, based on actual need. G. Fire prevention increased 3000/100%, new break out of previous item included in other expenses. H. Uniforms, Vehicle, Fuel all increased 100% due to breakout out detail of previously grouped expense. I. Computer maintenance contract increased 7000/100%, new computer contract need. j. Office furniture increased \$1000/100% due to needed purchase. K. Computer replacement increased \$2000 or 100% due to new computers needed. L. Equipment increased \$10000/100% for misc fire equipment needs. M. Other miscellaneous expenses moved up into cost of operations lines. N. Capital appropriations decreased by 78,367/61%, due to prior year purchase of Fire Official vehicle.
