

**TOWNSHIP OF EDGEWATER PARK  
ORDINANCE 2009-12**

**SPECIAL EMERGENCY APPROPRIATION PURSUANT TO N.J.S.A.: 4-53 FOR  
THE PURPOSE OF PREPARATION AND EXECUTION TO COVER EXPENSES  
RELATED TO CONTRACTUAL OBLIGATIONS FOR REVALUATION SERVICES  
AND OTHER RELATED COSTS AS A COMPONENT TO COMPLETE A  
PROGRAM OF REASSESSMENT OF REAL PROPERTY**

**WHEREAS**, it has been found necessary to make an Emergency Appropriation to meet certain extraordinary expenses incurred, or to be incurred for the preparation and execution to cover expenses related to Contractual obligations for Revaluation Services and other related costs as a component to complete a program of reassessment of real property for the use of the local assessor; and

**WHEREAS**, N.J.S. 40A:4-53 provides that it shall be lawful to make such appropriation, which appropriation and/or the “special emergency notes” issued to finance the same shall be provided for in succeeding annual budgets by the inclusion of an appropriation of at least one-fifth of the amount authorized pursuant to this act.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Edgewater Park, in the County of Burlington, (not less than two-thirds of all the members thereof affirmatively concurring) that in accordance with the provisions of N.J.S. 40A:4-55:

1. An emergency appropriation be and the same is hereby made for:  
Tax Assessor  
Other Expenses:  
Contractual obligations for Revaluation Services  
and other related costs. . . . . \$180,400.00
2. That said emergency appropriation shall be provided for in the budgets of the next succeeding years by the inclusion of not less than \$36,080.00 (must be at least one-fifth of the total amount) in each of the next succeeding annual budgets.
3. To the extent that any previous ordinance or resolution is inconsistent herewith or contradictory hereto, said ordinance or resolution is hereby repealed or amended to the extent necessary to make it consistent herewith.

**NOTICE**

The foregoing was introduced by the Edgewater Park Township Committee at its meeting held on September 15, 2009. This ordinance will be consider for adoption of final reading and public hearing to be held on October 6, 2009 at 7:00 PM, or shortly thereafter, and place to which such meeting may be adjourned, in the Municipal Building, 400 Delanco Road, Edgewater Park, New Jersey. At which time and place all persons interested will be given an opportunity to be heard concerning said Ordinance. During the week prior to and up to and including the date of such meeting, copies of said ordinance will be made available at the Clerk’s office to the members of the general public who shall request the same.
