

TOWNSHIP OF EDGEWATER PARK

ORDINANCE NO. 2013-7

AN ORDINANCE OF THE TOWNSHIP OF EDGEWATER PARK, IN THE COUNTY OF BURLINGTON, AUTHORIZING THE CODIFICATION AND REVISION OF THE ORDINANCES OF THE TOWNSHIP OF EDGEWATER PARK AND AUTHORIZING A SPECIAL EMERGENCY APPROPRIATION PURSUANT TO THE PROVISIONS OF N.J.S.A. 40A:4-53 et seq.

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF EDGEWATER PARK, COUNTY OF BURLINGTON, NEW JERSEY pursuant to the provisions of N.J.S.A. 40A:4-53, et seq. and N.J.S.A. 40:49-4

Section 1. A revision and codification of the ordinances of the Township of Edgewater Park, County of Burlington and State of New Jersey, pursuant to the statutes provided therefore, N.J.S.A. 40:49-4, be and the same is hereby authorized. Upon resolution of the Township Committee approving the contract for the codification the Mayor and Township Clerk designated therein are authorized to enter into a contract with any person, firm or corporation for such revision and codification.

Section 2. It is hereby determined that no appropriation has been made in any budget or budgets of the Township of Edgewater Park heretofore adopted to provide for the purposes authorized in § 1-1 hereof. There is hereby authorized, pursuant to the provisions of N.J.S.A. 40A:4-53 et seq., a special emergency appropriation in the sum of \$25,000.00 to be used in whole or in part to meet the cost of the aforesaid purposes.

Section 3. Financing. The special emergency appropriation made in Section 2 hereof shall be financed in accordance with a resolution or resolutions of the Township Council adopted pursuant to the provisions of N.J.S.A. 40A:4-55.

NOTICE

The foregoing ordinance was introduced by the Edgewater Park Township Committee at its meeting held on July 23, 2013. This ordinance will be considered for adoption after final reading and public hearing to be held on August 20, 2013 at 7:30 PM, or shortly thereafter, and place to which such meeting may be adjourned, in the Municipal Building, 400 Delanco Road, Edgewater Park, New Jersey. At that time and place all persons interested will be given an opportunity to be heard concerning the Ordinance. It is the purpose of the ordinance to authorize the codification of the Township Ordinances and to provide the funding by a special emergency appropriation to be paid over the term of 5-years as provided by law. During the week prior to and up to and including the date of such meeting, copies of the ordinance will be made available at the Clerk's office to the members of the general public who shall request the same.
